Artist Guidelines

GFAA Winter Show at Trinity United Methodist Church

Exhibit Committee reserves the right to reject any work of art because of space limitations or subject matter.

Only artwork that can be hung on the existing hanging system or displayed in our Object Display Case will be accepted for exhibition.

Artwork must be framed with a wire hanger attached, ready to hang.

The art / object display case facilitates the display of 3-dimensional objects (small artwork, photographs, carvings, glass work, fiber art, needlework, basketry, woodwork and other fine art crafts, and jewelry. The glass shelves are attractively lighted and secured by lock. Each shelf is approx. 5 feet in length and 12"-14" deep.

Participating artists are encouraged to submit an **Artist Bio**. The Artist Bio should accompany your Application and Liability Release.

An executed **Liability Release** (see below) must be submitted along with your Application.

Entry fees are to be paid at the time of art drop-off – checks are to be made **payable to GFAA**.

Attach a **label** with your name, phone number, and name of artwork on the back of each piece of your artwork.

Flyers announcing the reception will be available for pick up and distribution by all artists at the art drop-off.

We expect all artwork to hang until the pick-up date. However, should a piece of art be sold during the show and the purchaser wish to take immediate possession of the piece, the artist may be invited to submit a replacement piece of art for the balance of the show.

Brochures located in high traffic areas of the building will contain Information as to how viewers can contact artists for purchases.

Liability Release - Trinity United Methodist Church
