"Inspired by Song, Poem or Piece of Wisdom" Judged Art Exhibit Guidelines at The Gallery at Oak Hammock (OH) at the University of Florida

ENTRY DUE DATE: MARCH 15, 2021; Exhibit Dates: April 11 – July 10, 2021

1. Submit up to 3 art works of any medium that represent your inspiration of a song, poem or piece of wisdom. Include a paragraph of less than 40 words (to be placed next to each artwork) that briefly describes your inspiration source. Artwork not eligible are those that previously won an award at judged shows at Oak Hammock (OH) and those previously shown at OH Art Gallery in the prior 2 years. Artist must be at least 18 years old. Number of pieces accepted depends on total submissions.

<u>2D ART</u>: Any medium, framed or gallery wrapped ready for hanging by wire; sawtooth hangers prohibited. Unframed fiber art requires a rod and wiring for hanging. Max perimeter: 160" <u>Stained Glass</u>: Art must be ready to hang with thin chain, wire or monofilament line. Max height: 20", width: 30"; max weight: 20 Lbs.

<u>3 D Art for Stands</u>: The art must rest on your stable base. Max depth: 20", height: 36", max weight: 20 lbs, max width for base: 14". Electric outlets are nearby for selected pieces.

- **2.** The **SUBJECT MATTER** should respect diverse views- no controversial political or religious subjects. Display of human figure should be artistic, in good taste, and aesthetically pleasing. Oak Hammock residents or staff portrayed in artworks will have given their permission to be included as shown.
- 3. <u>DUE DATE: MARCH 15.</u> Submit jpegs (preferred) CD or prints of artwork with artist name and titles. Include application and other relevant forms either by 1) email to <u>jane@paintingsbyjane.com</u> OR 2) regular mail to: Jane Polkowski Levy, 2434 SW 50th Blvd, Gainesville, Fl 32608; OR 3) leave in Yellow Art League folder at OH reception desk.
- **4.** ENTRY FEE for up to 3 pieces: \$15 for non OH artists, \$10 for OH artists. Make check out to "Oak Hammock at the University of Florida AND write in the memo part: "Art League". Send to address in #3 above OR leave in Yellow Art League folder at OH reception desk.
- 5. Required to exhibit: 1) Artist's release of liability and waiver of claims form is required by Oak Hammock to exhibit in OH Gallery and 2) a brief description up to 40 words for each artwork that describes your inspiration source.
- **6.** Artist will be notified by March 29 of accepted artwork.
- **7.** Depending upon COVID conditions, you will be contacted about the specific time and place to deliver artwork on April 11.
- **8. Sales: There is no commission fee. All sales are handled directly by you.** Complete the "How to Contact the Artist" sheet to enable prospects to contact you.
- **9.** You are requested to leave the works until the end of the show. If an item must be removed earlier, contact jane@paintingsbyjane.com or call (352) 377-5979.
- **10.** Artist bio/statement for viewers: maximum 1 page
- **11. Opening reception**: We do not know if there will be an onsite opening reception, which will depend on COVID conditions. We are planning to have a video made of all the artworks along with the judges' awards presentation at that time.
- **12. Check-out** will be Saturday morning, July 10, 2021. Details will be sent prior to then.

Releasor further agrees to indemnify and hold harmless Releasee and its successors, agents, staff, employees, volunteers, officers and directors from any such claims, damages, lawsuits or causes of action, including, without limitation, those it might bring in breach of this Agreement.
